

## **2018 BYODD iPad Code of Conduct**

### *Rationale:*

The school's Bring Your Own Designated Device (BYODD) Program affords the opportunity for our students to enter a new world of curriculum possibilities, allowing engagement and involvement in their learning. Learning experiences across the school are purposefully designed to develop the attributes of a life-long learner. In this way, each student learns to develop and demonstrate the knowledge, skills, practices and attitudes necessary to be an engaged, robust, 21st Century citizen capable of shaping our future.

### *Equipment*

As part of the BYODD program, students will need to bring either an iPad or iPad Mini that is iOS 11 capable. Wi-fi iPads are preferable. However, if 3G or 4G is the only available device, students may bring the device so long as the 3G and 4G capabilities are switched off within the school environment. Each student will also need to supply a personal set of headphones. A protective cover and screen guard are highly recommended.

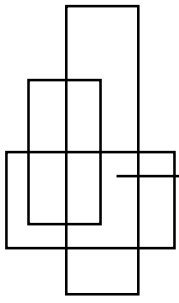
### *Usage*

Devices are to be used when instructed by a teacher during class only. Teachers will have the right to look at a student's device at any time if deemed necessary. To facilitate this, all permissions for Apple Classroom need to be accepted. Also, Bluetooth needs to be enabled at all times. Students may be required to register for some apps using their school email and school password as determined by their teacher.

### *School Owned Devices*

School owned devices may be used. However, this will require an application to the principal and is subject to approval and a rental fee will apply.





## *Guidelines for Participation*

- Students will bring their device every day and parents will be notified if students fail to do this more than once.
- Parents and students both agree to the terms and conditions of the program, by signing the code of conduct document.
- The apps requested by the school will be downloaded within 7 days of notification.
- **Parents and students are responsible for any breakages that occur and repairs will be completed as soon as possible. Student will be able to use a school device during school hours. After two weeks of use, students will be charged \$5.00 a week until their iPad is back in use.**

## *Conditions of Access*

Students are responsible for:

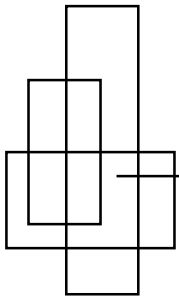
- The care of their device at all times.
- Adhering to Peakhurst Public School's BYODD Usage Code of Conduct.
- **Ensuring their device is fully charged each day.**
- Ensuring 3G and 4G capabilities are switched off and Bluetooth is enabled.
- Using a respectful tone of voice and language when communicating online. All school rules and consequences related to harassment apply.
- Using appropriate grammar instead of texting language.

Students are not to:

- Use social media such as; Facebook, Instagram, Facetime or any other messaging/video Apps unless instructed by a teacher.
- Borrow or gain access to or interfere with in any way, another student's device.
- Use a Smart Phone (or other such device) as a wireless hot spot for their device or use 3G or 4G internet connection.
- Post photos or videos of anybody without permission.

Students who fail to comply with this "BYODD Code of Conduct", will be dealt with in accordance with the Peakhurst Public School Discipline Policy.





## *Caring for Devices*

It is recommended that students adhere to the following conditions:

- Always store the device in a suitable protective cover;
- Do not attempt to remove the battery pack from the device;
- Do not expose the device to heat, dust, moisture, magnets or heavy shock or vibration;
- Keep food and drinks well away from the device

## *Internet Usage*

Use of devices by students is governed by this agreement. Any inappropriate use of the internet is unacceptable and is subject to disciplinary action and exclusion from the school networks and resources. Students must use their own DoE login and password to access the internet. The DoE provides secure and appropriate internet access for students.

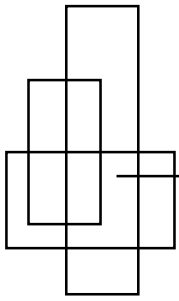
## *Additional Apps*

All additional apps required will be notified to parents via School E-News or a written note. Students will not be able to download these apps at school. It is recommended that parents, not students, download these apps at home as iTunes is linked to your bank or credit/debit card details.

## *Technical Support*

If students have an issue with their device they may report it to the classroom teacher who will help resolve the issue if possible. However, it is not the schools responsibility to solve these problems and if no solution can be found it is the parent's responsibility to contact Apple Support.
